**AMENDMENT TO DECLARATION OF CONDOMINIUM
FLY-IN CHALETS A**

Fly-In Chalets A is a condominium project located in Waitsfield, Vermont, established pursuant to the Fly-In Chalets A Declaration of Condominium, including all Appendices thereto, dated April 30, 1979 and recorded in Book 39 Page 112 of the Waitsfield Land Records (the Declaration).

This Amendment to the Fly-In Chalets A Declaration of Condominium is made pursuant to Section 16 of the Declaration, the provisions of Vermont Statutes Annotated, Title 27, Chapter 15, and the applicable provisions of Vermont Statutes Annotated, Title 27-A.

NOW THEREFORE, the membership in the Association hereby amends the Declaration as follows:

Section 17, Introduction is amended to read as follows:

The operation of the property shall be by an incorporated Association, which shall be organized and shall fulfill its function pursuant to the following provisions.

Section 17, subsection (a) is amended to read as follows:

Name: The name of the Association shall be Fly-In Chalets A, Inc.

All references to the form and name of the Association shall be updated throughout the entire Declaration and all Appendices thereto.
