

## KNOW ALL MEN BY THESE PRESENTS

That we, Garry N. Crothers and Sharon S. Crothers  
of Roxbury, in the County of \_\_\_\_\_ and State of Vermont, Grantors,  
in consideration of one dollar and other valuable considerations  
paid to our full satisfaction by

A. G. Bullock, Jr. and John Malcom

Owners of land in Warren, County of Washington, State of Vermont,  
grantees, by these presents do freely GIVE, GRANT, SELL, CONVEY  
and CONFIRM unto the said grantees,

A. G. Bullock, Jr. and John Malcom

and their heirs and assigns forever an easement over a certain  
piece of land in Warren, Washington County, Vermont, described  
as follows:

The purpose of the easement is so that the grantees may maintain  
their view from Camels Hump Mountain to the Lincoln Gap, westerly  
from the grantees land, over the subject grantors land.

The grantors give the grantees the right to enter and remove flora  
affecting the described view from the grantors premises.

The grantees agree to cut and burn the cuttings in a neat manner  
leaving entire trunks for the grantor to take.

The easement is over a portion of the lands conveyed to the  
grantors by Warrantee Deed of Rudolph F. Elliott and Mary J. Elliott  
dated 10-28-64, Recorded Book 26, Page 246, of the Warren Land Records.

Said easement herein conveyed is more completely described as  
follows:

A portion of the Rudolph F. Elliott and Mary J. Elliott/Garry N.  
Crothers and Sharon S. Crothers Deed, further described as,  
beginning at a pin referred to, see Lester H. Senor and Arlene D.  
Senor/Linwood W., Bruce T., and Nancy B. Joep plat, as sta. 1.  
That same sta. 1 is referred to in the Lester H. Senor and Arlene  
D. Senor/A. G. Bullock, Jr. plat as sta. 3, that pin referred to  
for the purposes of this easement on the attached Garry N. Crothers  
and Sharon S. Crothers/A. G. Bullock, Jr. and John Malcom plat  
as pin A,

Thence NNE, more or less along a fallen fence line, being that of  
the grantors and grantees as described in the Elliott/Crothers Deed  
and the George Elliott and Eugenie Elliott/A. G. Bullock, Jr. and  
John Malcom Deed

at a point on the line of the grantors and Joep, as that line is

The grantors covenant that they are the sole owners of the premises  
and have good title to convey it free from encumbrance, except a  
right of way for an electric line, and we will warrant and defend  
the same.
